All bidders must provide proof of registration from ministry of public works and registration from local authority granting them permit to perform the works and services required in this Project. All bidders are required to conduct ocular inspection of the project site in order to gain good understanding to the project requirements and the surrounding environment of the project site which will have impact on the implementation strategy to be used in the Project.
